The above recognition is subject to the following conditions:-

- 1. The temporary recognition accorded to the school is valid up to **31.12.2025** and is to be renewed at the end of three years.
- 2. The grant of recognition is available initially for classes **PreKG to VIII** Standard and to be extended for Secondary/ Senior Secondary classes subsequently in due course of time.
- 3. The School shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Tamil Nadu Right of Children to Free and Compulsory Education Rules, 2011.  - (b) On the ground of religion, caste or race, place of birth or any of them.
- The school shall ensure that :-
 - (a) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - (b) No child shall be subjected to physical punishment or mental harassment.
 - (c) No child is required to pass any board examination till the completion of elementary education
 - (d) Inclusion of students with disabilities/ special need as per provision of the Persons with Disabilities Act, 2016.
- 7. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority
- No unrecognized classes shall run within the premises of the school or in any other place in the name of School.
- 9. The School building plan must have been approved by the competent authorities as per relevant rules. The School building or other structures and the land are to be used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respects are the whole responsibility of the school management.
